

UOI' has been filed before the Hon'ble Supreme Court challenging The Tribunals, Appellate Tribunal and other Authorities (Qualifications, Experience and other Conditions of Service of Members) Rules, 2017. In terms of the Hon'ble Supreme Court order dated 09.02.2018 in W.P (C) No. 279/2017, the terms and conditions of the Members shall be governed by the CESTAT Members (Recruitment and Conditions of Service) Rules, 1987 pending its final outcome. It may be noted that no reservation is provided for SC/ST Candidates for making appointment to the post.

3. In accordance with the provisions of Section 129(2A) of the Customs Act, 1962, read with the Customs, Excise and Service Tax Appellate Tribunals Members (Recruitment and Conditions of Service) Rules, 1987, a person is qualified for appointment as Member (Technical) of the Tribunal if he has been a member of the Indian Customs & Central Excise Service Group 'A' and has held the post of Commissioner of Customs and/or Central Excise or any equivalent or higher post for at least three years, and has attained the age of 45 years. Meanwhile, as per the opinion given by the Ministry of Law and Justice (Department of Legal Affairs), all serving/retired officers who otherwise fulfill the eligibility criteria for the post of Member (Technical) as Stipulated under Rules 3(2) of the Customs, Excise and Service Tax Appellate Tribunal Members (Recruitment and Conditions of Service) Rule, 1987 are also eligible.
