in the DGCI, AZU / RRU on deputation- reg.**

The Directorate General of GST Intelligence, Ahmedabad Zonal Unit is in the process of drawing up a panel of willing and suitable candidates for filling up post of 05 Sr. Intelligence Officers at the Zonal unit, Ahmedabad and 02 Sr. Intelligence Officers at Regional Unit, Rajkot. This post will be filled up on deputation basis from the officer of equivalent grade of Customs and Central GST / Central Excise.

2. The selected officer, while working on deputation in the Directorate in the grade of Sr. Intelligence Officer, will be entitled for deputation allowances as admissible. Normally, the deputation is for a period of five years which can be extendable by another two years, subject to willingness of the officers, his/her performance, concurrence of his/her parent commissionerates and approval of the competent authority. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw.

3. It is requested that the Circular may please be brought to the notice of all the formation under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may be furnished :

- i. Complete Bio-Data and willingness letter of the officer along with History of Previous Posting
- ii. APAR/ACR Grading for the last 5 years duly verified and attested by the Additional / Joint Commissioner (P&V)
- iii. Vigilance Clearance Certificate
- iv. No objection Certificate from the competent authority to relieve the officer in the event of his/her selection
