Sub: Preparation of panel for appointment of three (03) Intelligence Officer/Inspector at Guwahati Zonal Unit, Guwahati under Directorate General of Goods and Services Tax Intelligence (DGGI), on Deputation basis – reg.

The Directorate General of GST Intelligence, Guwahati Zonal Unit, is in the process of drawing a panel of suitable candidates for filling up three (03) vacancies in the grade of Intelligence Officer in the Zonal Unit, Guwahati.

- It is proposed to fill up the vacant post of Intelligence Officer by appointing suitable Officers on deputation basis from the grade of Inspector of GST and Central Excise/Customs. Officers who have been granted financial up-gradation under MACP Scheme, are also eligible for the said post.
- The selected officers, while working in the Directorate General in the grade of Intelligence Officer, will be entitled to special allowance as admissible in terms of Government of India's instruction issued from time to time. Normally, the deputation is for a period of five (05) years which is extendable by another two (02) years, one year at a time, subject to the willingness of the officer, his/her performance, concurrence of his/her parent Commissionerate and approval of the Competent Authority.
- It may also be pertinent to mention here that the option for deputation in Directorate General of GST Intelligence, Guwahati Zonal Unit, once exercised cannot be withdrawn under any circumstances.
- It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may also be sent for evaluation by this Directorate General:-
  - Complete bio-data and willingness of the Officer along with history of postings.
  - List of cases booked on his own information/intelligence along with duty involved and recovered.
  - APAR gradings for the last 5 years verified and attested by the Addl./Joint Commissioner (P&V).

(iv) Vigilance Clearance, and

(v) "No objection Certificate" from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.

6. The above information/details may kindly be furnished to this Directorate latest by 25.02.2019.
