Sub: Posting of Air Customs Officers to Anna International Airport, Chennai
against 25% quota from Central Excise Zones – reg.

Please refer to the subject cited above.

As per the Annexure I of the Ministry's letter F. No. A-11019/102/91-Ad.IV dated 21.10.1993, Inspectors are to be filled under the 25% quota from the respective CGST & Central Excise Zones / Commissionerates as Air Customs Officers.

Further, as per Para 3 (ii) of the Board's letter F.No. A-11019/22/2007-Ad.IV dated 22.12.2008, in case, if adequate officers are not being sponsored by the respective CGST & Central Excise Zones / Commissionerates, the same is extended to all CGST & Central Excise Formations.

As on date, 16 posts are lying vacant, at Anna International Airport, Chennai on deputation basis.

Hence, it is requested that willing officers may be deputed from your Commissionerate for Air Customs Officers under 25% quota at Anna International Airport, Chennai following the selection procedures for deputation at the earliest.
