- Order regarding extension of loan period of Shri Jyotiraditya, IRS for appointment with NIA on loan basis, has been issued vide Officer Order No. 85/2018 dated 24.05.2018.
- Order regarding placement of services of Shri Alok Shukla, IRS as Minister (Customs) in Permanent Mission of India (PMI) to the World Trade Organisation (WTO) Geneva under the Department of Commerce, has been issued vide Office Order No. 86/2018 dated 25.05.2018.
